Minutes of Previous Meeting The minutes of the previous meeting were approved and signed.

# Matters Arising

Cllr Archer said that the **War Memorial** Trust were now asking for two more quotes from companies that use no chemicals in their cleaning process ...these are now being obtained. The Clerk reported that the **Manuden Speed Monitoring Group** had checked the traffic on two occasions and the results sent to CSWatch Essex, there they will be checked and letters sent out to motorists who are breaking the speed limit.

The council discussed the **Road Signs** on the road to the play park and to Maggots End. ECC Highways have said the road to the play park is not their responsibility. There was some discussion over where the placement of the Maggots End signs should be. It was suggested that Rissa Long should be contacted regarding repeater signs on the Clavering Road.

At the **Local Highways Panel Meeting** it was provisionally agreed to fund the design works required for the possible kerbing and new drainage works, this will hopefully be confirmed in March. The Council are also pleased to note that we have new Village gates fitted at each end of the village.

The councillors had received mixed messages regarding the **Ultrafast Broadband** .... **Gigaclear** project. Gigaclear appear to be proceeding well in Hunsdon but the information on their web page is very misleading and it was felt very unlikely that they will meet their initial targets.

#### Other issues

The date of the Village Clean up ..... March 18<sup>th.</sup> it is hoped to have a good turnout. It is some years since we entered for the 2017 Essex Village of the Year Competition and it was decided to investigate the possibility of our doing so this year. It was decided that the only Donations to "worthy causes" would continue to be to The Royal British Legion and to the Essex Air Ambulance Trust.

The councillors were happy to support the **Manuden Village Picnic on May 6<sup>th</sup>** and to have a widow display on behalf of the Parish Council.

**Open Gardens:** The subcommittee were very pleased to announce the profit of £1141.41 from the recent highly popular film showing of Grease, this enabled them to buy a new DVD player for, and make a donation of £400 to MVCC as well as a donation of £600 to the Pancreatic Cancer charity.

**Footpaths:** The Council agreed to the Berden PC request to add to add the cutting of footpaths 2 and 3 to their cutting program under their P3 agreement
