The minutes of the previous meeting were approved and signed.

**Matters
Arising**

Although **2a Mailers Lane** appears to be occupied there is nothing further to report until the results of an Ofsted Inspection are received. There has been a small amount of tidying at **4 Mailers Lane** but the garden is still very untidy and the UDC officers are taking legal action against the tenant.

There is nothing to report about the **War memorial lettering**. There was a detailed discussion regarding the way leaves being offered by **Gigaclear** and councillors agreed to investigate further.

Everyone agreed that the Village **Christmas Party** had been a great success and should definitely go ahead again in December 2018, the **Precept for 2018-19** was set at £9020.00 which is very close to a 3% increase.

The Chairman agreed to contact ECC regarding **Village signage**, with particular reference to the repeaters at the northern end of the village as well as to investigate more and better signage for MVCC. The Council agreed to buy a new rubbish bin for the **Village Green**. The Clerk had contacted RCCE to invite a representative **to speak** to the Council on the topic of **loneliness and help needed**.

**Other
issues**

BT reported that the phone box will be removed at some future date and it was decided to contact **St. John's Ambulance** in order to offer a **First Aid course with particular reference to using the Defibrillator**.

A **Highways Panel minute** caused some concern that the proposed kerbing at the northern end of the village may not happen and the clerk agreed to check on this. The problem of **Speeding in the village and road safety** was again discussed, following further complaints about the speed of cars along the main road and also the broken school Wig Wag signs. The suggestion of perhaps moving the flashing village speed signs to a better location was discussed and will be investigated also discussed were the possibility of "Twenty is plenty" signs from school children as well as cardboard cut outs. The suggestion of Highways doing a site visit to give advice on road safety measures will also be investigated. The broken Wig Wags have again been reported, but we have been informed that they won't be repaired or replaced at this time.

The Clerk was asked to report a row of **Leylandii** trees that are overgrowing the pavement at the top of Stewart's Way
