Matters Arising The meeting began with the **latest update on Planning application UTT/18/2258/OP.** This has now been withdrawn and the developer has submitted a new application. The Chairman and Clerk had both spoken with the planning officer and informed the Council what they believed may be some of the reasons for the developer doing this. They said they believed the planning officer was considering refusing the application on several fronts such as the rural aspect of the village and the effect the application may have on it. There were also other considerations such as the problems on entering the site as well as the amount of traffic that would be generated. As The Council only became aware of the new application earlier in the afternoon its details and the implications of it were not fully discussed, however the Council decided

to inform parishioners that, whatever their thoughts are on the application, they would need to contact Uttlesford again if they wish their comments to be considered. The Council then decided to **produce and distribute a leaflet** to inform villagers of the new application.

The Council were pleased to have received many very pleasing and positive comments regarding the **Christmas celebrations and activities.** The party was very well received and the date of Saturday 7th December was agreed for a similar event for Christmas 2019, it was, however, felt that a separate event, such as a Tea Dance, may need to be considered for some of the more senior members of the community. The Chairman signed the **Precept form setting the Precept at £9920.00** for the financial year ending 31st March 2020..

There was no more information on the **Kerbing issue** and Cllr Hannington had been informed that **Green Matters** would not be carrying out the requested hedge cutting until later this month or in February.
